2	Introductions and Apologies – the Chairperson asked all attendees to introduce themselves and apologies are listed above.

4	Cornwall AONB Business Update – Summary	
	4.1 Signing of the Partnership Agreement - the Partnership Agreement for 2022-2027 has now been signed by all Partners and everyone was thanked for actioning this.	
	4.2 National Landscape Re-brand – Melodie confirmed the protected landscape will still be known as AONBs in law (CROW Act 2000) but will be renamed 'National Landscape' publicly to align and level up AONBs with National Parks. NAAONB will lead on comms of this nationally, and all local AONBs promoting awareness and making changes locally to their website, using the new logo in their communications and interpretation etc	
	All AONBs in the country have a new logo which has been produced on behalf of NAAONB to provide a unified branding look across the AONB National Landscapes family. The Cornwall National Landscape logo is based on the current logo design as it was still felt fit for purpose and will help to maintain continuity and recognition of the branding work that has already taken place.	
	 4.3 Continued recruitment of new Partnership Chairperson – Emma expressed huge thanks to Gill for continuing to lead the Partnership in the interim until a new Chairperson is recruited. 4.4 re-advert of MI Project manager post – <u>first</u> round of recruitment was not successful so the role has been readvertised and the closing date is 10 Oct 2023.

Formal note of thanks to Natalie - Gill asked that it be recorded in the minutes that thanks be passed onto Natalie Haly, for all the great work she did for the Monumental Improvement project during her time with the AONB team.

NAAONB Annual Conference – Emma and Melodie attended the Annual Conference with staff from all AONBs and other organisations across the country. Emma and Melodie were invited to run a workshop related to AONB Trusts. It was a useful info sharing session about how to create the alignment of the Trust and AONB Team – the challenges of aligning the two organisations but also keeping them separate. Other AONBs/Trusts have experienced similar issues in the process, and some AONBs are further down the line of setting up Trusts than others.

Cornwall Council's Neighbourhoods Overview & Scrutiny Committee (NOSC) – Emma presented to the Committee on 5 Oct 2023 to report and update on the delivery and actions of the Management Plan 2022-2027, which is one year on in its delivery. Planning, designations and funding was all discussed.

Martyn Alvey thanked Emma for an excellent report and presentation which included an indepth question and answer session.

5 Presentations by Partners and Stakeholders:

5.1 ERCCIS – Dr Emma Rosenfeld, ERCCIS Manager and Cornwall Wildlife Trust Evidence & Spatial Lead

ERCCIS is a central resource that collects, manages and disseminates information and data.

ERCCIS holds both species and habitat data collected by volunteers, biological recorders and across Cornwall Wildlife Trust. ERCCIS also undertake project work such as the Ancient Woodland inventory for Cornwall which is to help understand the history of Cornish Woodland. This is a national project to which ERCCIS and Cornwall is involved.

ERCCIS is unfortunately pre-occupied with the state of nature and decline of nature, with the aim to have a recovery in nature.

Increased coverage in a more structured way of data collection is needed in addition to the more adhoc data collection which is also taking place. So a structured monitoring scheme across Cornwall is something that is being worked on, with University of Exeter, to undertake regular, structured monitoring. One example is the Butterfly Monitoring scheme that has been recorded in some parts of Cornwall for many years, but would also benefit from a more structured approach to collecting and recording data.

Cornwall Wildlife Trust has more than 5500 acres of land across 59 nature reserves. The aim is for these to be better managed and monitored. Some of the reserves are within the AONB. Rewilding at Helman Tor is one of the projects and ensuring required techniques and structured monitoring is in place there as a trial for other sites.

Emma Rosenfeld was thanked for her interesting presentation. The work of ERCCIS is meeting the AONB Management Plan Objective: *NRLM-Ob2 Support opportunities to further understand the state of the AONB's biodiversity and geodiversity resource, including mitigation to avoid recreational impacts upon the qualifying features of the SAC or SPA*.

Round Table update – partners asked to briefly update on their work within the AONB and related to AONB Management Plan Strategy:

SWCP, **Aletha Mays** – as part of this year's 50th anniversary of the SWCP celebrations over 1000 people did a relay walk along the coast path and there was a photo exhibition. The Coast Path Connectors project is going well.

Cornwall Council, Strategic Historic Environment, Ann Reynolds – the recent Heritage Expo event was very successful, held on 2 days at Godolphin House. The first day was for students to learn more about heritage careers and obtain advice, and the second day was for general public which attracted many visitors to the groups and organisations exhibiting their stands there. Several AONB Partners had a stand there, including the Cornwall AONB Monumental Improvement Project team.

ESI, David Baker – local nature recovery strategy work taking place with Cornwall Council and others. Starting work with farmers with the RENEW project so would welcome discussion and input from AONB partners on this. David suggested holding a seminar with the AONB for all partners and stakeholders to discuss and it was agreed this would be very beneficial.

Cornwall Heritage Trust, Cathy Woolcock – CREST (Cornwall Rural Education & Skills Trust) is up and running with lots of volunteering taking place on sites, schools workshops with the outreach officer. CHT held their heritage event at Heligan which was also a

successful and well attended event. Penwith Landscape Partnership (PLP) legacy work is continuing with the volunteers.

Cornwall Council, Martyn Alvey - LNP and LNRS consultation is still open – via Let's Talk Cornwall so anyone can contribute to that consultation <u>A Nature Recovery Strategy for Cornwall and the Isles of Scilly | Let's Talk Cornwall</u>, also the LAEP consultation call for evidence for any partners and residents to provide a response <u>Cornwall and Isles of Scilly Local Area Energy Plan | Let's Talk Cornwall</u>

Cornwall Council, Protected Landscapes Manager, Dan Cooke - looking at funding and asset management across the Cornwall AONB, Tamar Valley AONB, WHS and Council's Heritage Service. The Countryside Services have put in a bid to Good Growth funding. Tamar Valley AONB team are now starting their Management Plan review and will be looking to benefit from the experience/info share with Cornwall AONB team on this. Storage space has been secured for Cornwall AONB and WHS to have a shared space for storage of events kit, display boards etc

CRCC, Gemma Finnegan – at the recent Inclusion Cornwall AGM a presentation was given on the Inclusion Research project that the AONB had funded. There was a sensory video as part of that presentation which worked well and it was a great piece of work.

Cornwall AONB Trust, Hugh St Aubyn – the Trust is focusing on developing its business strategy with refreshed business plan to be in a better position going forward with a revised vision for the Trust. Hugh will present this further at a future AONB Partnership meeting.

Environment Agency, Lisa Goodall – involved in Natural Flood Management project in Mousehole, working with Cornwall Wildlife Trust. Also a project in Mevagissey looking at flood management with opportunity for habitat creation. Both these are supporting the delivery of the AONB Management Plan Objective: NRLM-Ob5 Support a catchment-based approach to soil conservation and river, estuarine and bathing water quality within the AONB, to reduce flood risk and improve catchment resilience.

CC Public Health, Gwyn Williams, reminder to all Partners encouraged to undertake the Mental Health First Aid training courses, which are offered at a very reasonable subsidised rate – these can be booked via Mental Health First Aid (MHFA) - Healthy Cornwall and there are also some free places for farmers – contact Gwyn.Williams@cornwall.gov.uk.

The Annual Report from Director of CC Public Health – includes an environmental section which looks at environmental factors such as air pollution.

World Heritage Site, Lesley Strong, Stakeholder Engagement Officer – only been in post for a few weeks. Attended the Heritage Expo and Heligan CHT heritage event. Just run a photo quiz and Cornish Distinctiveness work taking place now.

Visit Cornwall, Malcolm Bell – new Visit Cornwall website still being completed as now changed providers etc.

Following a review of tourism structures in England the Government agreed to the establishment of around 40 Local Visitor Economy Partnerships, which would form the

	backbone of a national portfolio of organisations to support the marketing and development of tourism going forward.	
	Visit Cornwall led a partnership to apply for Cornwall and the Isles of Scilly to be approved as one of the new Local Visitor Economy Partnership (LVEP). The bid was successful in May 2023 and now the work starts to form the governance and operational arrangements. Malcolm Bell stated that the protected landscapes would need to be represented on the new body.	
	Manchester have created a business improvement district for tourism, charging tourists £1 which goes into the business plan. This is something that is at no cost to businesses, and it is something that Cornwall is considering in its regenerative tourism aims.	
7	Presentations by AONB Team:	
	a) Project Pipeline and Heat Map – Coralie has been developing a process and system/criteria for projects to get them ready and worked up for potential funding opportunities and also a way to review/assess partner projects that come forward. A spreadsheet and scoring matrix has been developed, which considers Management Plan actions and business plan resources.	
	The idea of a Heat Map is also being worked up to visually show where in the AONB there are currently projects, where there are opportunities for the AONB to work in other sections of the AONB.	
	LINC and LNP project submissions have also recently been submitted for funding – outcome awaited on those.	
8	AONB Team Projects and Planning Update – a briefing paper had been circulated with the agenda papers.	
	8.1 Emma – Partnership Manager update – in September, Defra provided an opportunity to bid for Access funding which was not expected in Year 2. The AONB team have submitted a bid for funding via a tight deadline and outcome is awaited.
